- Free for all Patients
- Has flexible seating
- 8 walking passengers or 6 walking and a wheelchair
- Covered waiting facilities inside reception areas and at Main Hospital car park.
- Circular route (20-25 minutes round trip)
- Service 08.30 -17.00 Monday to Friday from Main Multi-storey car park.

FunderFinder©

Disability Cambridgeshire is one of over 1,000 licensees of FunderFinder software helping us to help you track down charitable trusts and foundations to find some funding.

What does this involve?

You call Disability Cambridgeshire on 01480 839192 and book a time for an adviser to ring you back and go through a series of guided questions. You need to allow about 20 – 30 minutes. People often ask why there are so many questions. This is what FunderFinder has to say:

“This is simply because trusts give grants for all sorts of reasons. Some trusts fund people because they live in a certain place, others because people once did a particular job. Some give grants to particular nationalities or religious groups...The key point is to consider whether you have a strong relationship with a particular group.”

What happens next?

After the search the adviser sends you a list of the trusts that the software has identified. You will probably have to apply for yourself but we are always ready to lend a hand if needed. You can be sure that all this information is kept confidentially in the same way that any information about people who consult Disability Cambridgeshire is kept securely.

Hate Crime – Who’s problem?

- Each year the Crown Prosecution Service (CPS) Cambridgeshire prosecutes over 2 hate crimes per week, and the numbers are growing.
- Crime motivated by hate can have a devastating effect on the victim’s life. Hate can be based on race, religion, age, sexual orientation or disability.
- The way the CPS approaches hate crime prosecution has a major bearing on public confidence and the encouragement for new victims to report crimes against them.

Social Security Benefit Quirk

A quirk of the April 2010 Social Security benefit uprating regulations is that many age 25 plus recipients of the highest rate care component of Disability Living Allowance and the Incapacity Benefit long term rate with the under 35 age addition will become eligible for some Income Support, with the consequential benefits of automatic exemption from health charges and entitlement to cold weather payments and Social Fund budgeting loans.

These are people who cannot claim the severe disability premium as part of their 'applicable amount' because a carer receives Carers Allowance for looking after them or they do not live alone.

From week commencing 12.4.10 the 'applicable amount' or minimum income entitlement for a person between the ages of 25 and 59 rises to £65.45 per week with additional premiums for disability and enhanced disability of £28 and £13.65 respectively, **providing the highest rate care component of Disability Living Allowance is in payment.** These rates, along with other means tested benefits, have moved up in accordance with the Rossi index.

Contributory benefits, such as Incapacity Benefit (including Incapacity Benefit in Youth) increase in line with the Retail Price Index except that regulations facilitating the introduction of Employment and Support Allowance, which will eventually replace Incapacity Benefit, provide for a **reduction** in Incapacity Benefit age- related additions from week commencing 12.4.10.

This has the apparently unintended consequence of bringing people in receipt of DLA highest care component and the long-term rate of Incapacity Benefit of £91.40 per week with the under age 35 age addition of £15 per week to a position where their National Insurance income is 70p per week less than their 'applicable amount'.

Disability Living Allowance is not treated as income but savings in excess of £6,000 generate an income of £1 per week for each £250, or part thereof. This means that savings of £6001 would give you the £1 of income that would exclude you from Income Support when added to your Incapacity Benefit.

Cambridge City Council and Housing Adaptations

On February 1st City resident Georgie Deards received a letter from Cambridge City Council to say that she would have to pay a service charge on her disability equipment which would have cost her £230.10 per year (or £4.43 per week) and this would happen from April 2010.

Georgie felt that this was an unfair tax on disabled people. After a lot of campaigning Georgie and Gerri Bird of Disability Cambridgeshire went to the Cambridge City Council Housing Management Board meeting on 23rd March 2010 to put the case forward. They said how unfair this was to disabled residents in the city and that the Cambridge City Council was discriminating against disabled people.

The outcome was that the council agreed to withdraw the charge on the existing adaptations, which was great news. The Committee will also be reviewing policy affecting new adaptations and tenants in the summer, but Georgie and Gerri will keep the fight going as they feel that this tax should never be charged.

Opportunities For Volunteering Project

Disability Cambridgeshire and Disability Huntingdonshire are currently working together on an exciting new Opportunity for Volunteering Project. Funded for three years by the NHS via Radar this project aims to deliver a six-month intensive training programme to volunteers.

Cheryn Rook, Volunteer Coordinator, explains:

“The programme will equip volunteers with the skills required to deliver advice, support and guidance on a myriad of disability information, such as the DDA, benefits and self-directed support.

As a former employee of the Royal National Institute for Deaf People I will also be delivering training on communication tactics with deaf and deafblind people. In addition, the volunteers will be offered the opportunity to undertake an NVQ level 2 in Advice and Guidance, with support from Huntingdon Regional College.

Our first group of volunteers are currently undergoing training and we are now looking for volunteers to start in the next group starting in the summer of 2010.

Did you know that six of the largest mobile phone companies no longer charge their customers for calls to the DWP 0800 benefit claim lines? The Department has agreed with 0², Orange, Tesco Mobile, T-Mobile, Virgin Mobile and Vodafone to end charges for these calls (Touchbase, DWP, Mar 2010). 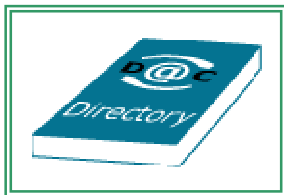
